- 2. If the applicant does not have a valid PAL, a Criminal Background Check is required and a copy presented with this Membership Application.
- 3. The KNC is insured through the CSSA and membership in this organization is mandatory. If you're a lifetime member with the CSSA or pay your own CSSA membership then you will be exempt from paying the CSSA fee, but you must provide proof of a valid membership every year.
- 4. Membership renewal is due by December 8th of each year, or you cease being a member.
